

PUBLIC NOTICE (2)

In the name of Allah the Merciful, the Compassionate

MR MOHAMMED ASLAM OF 34 BLENHEIM AVENUE, HIGHFIELD SOUTHAMPTON HAD FILED A CLAIM IN THE HIGH COURT ALLEGING THAT HE IS OWED £3,335,408 (THREE MILLIION THREE HUNDRED THIRTY FIVE THOUSAND FOUR HUNDRED AND EIGHT POUNDS) FOR BUILDING THE MOSQUE. HE DEMANDED THAT THIS AMOUNT SHOULD BE PAID TO HIM.

THE MOSQUE AS YOU MIGHT KNOW WAS BUILT THROUGH PUBLIC DONATIONS OF MANY INCLUDING THOSE FROM MOHAMMAD ASLAM AND HIS FAMILY FOR WHICH WE ALL REMAIN GRATEFUL.

DUE TO THE SPURIOUS CLAIMS OF MR ASLAM AND HIS TWO COLLEAGUES (HIS FAMILY MEMBERS) TO THE OWNERSHIP OF THE LAND UPON WHICH THE MOSQUE HAS BEEN BUILT A LONG AND EXPENSIVE COURT CASE HAD TO BE DEFENDED BY THE SMMTL.

THE HIGH COURT, EARLIER THIS YEAR, ORDERED THAT THE LAND UPON WHICH THE MOSQUE HAS BEEN BUILT AND WHICH HAD BELONGED TO THE LOCAL AUTHORITIES SHOULD BE TRANSFERRED TO THE SOUTHAMPTON MEDINA MOSQUE TRUST LIMITED. THE CLAIM OF MR ASLAM WAS REJECTED. MR ASLAM WAS ORDERED TO PAY HALF OF THE COSTS INCURRED BY THE SMMTL IN LITIGATION. MR ASLAM AND/OR HIS CO-DEFENDANTS HAVE SO FAR MADE NO OFFER TO PAY THE COSTS AWARDED AGAINST THEM.

THE TRANSFER OF LAND TO THE SMMTL HAS TAKEN PLACE IN ACCORDANCE WITH THE COURT ORDER ALTHOUGH MR ASLAM IS STILL NOT COMPLIANT WITH PART OF THAT ORDER.

MR ASLAM'S LATEST CLAIM ALLEGING THAT HE IS OWED THREE MILLION THREE HUNDRED THIRTY FIVE THOUSAND FOUR HUNDRED AND EIGHT POUNDS HAS ALSO BEEN DISMISSED BY THE COURT IN LONDON. MR ASLAM HAS BEEN ORDERED TO PAY SEVEN THOUSAND FIVE HUNDRED POUNDS TOWARDS COSTS INCURRED BY THE SMTL IN DEFENDING THE ACTION. THE SMMTL HAS SO FAR RECEIVED NO OFFER FROM MR ASLAM EITHER IN RELATION TO THE PREVIOUS COSTS THAT HE HAS BEEN ORDERED TO PAY OR THESE FRESH ONES.

THE AMOUNTS INCURRED BY THE SMMTL IN LEGAL COSTS HAVE BEEN SUBSTANTIAL BUT THERE WAS NO OPTION. WE ASK ALL TO PRAY THAT THESE UNREASONABLE AND VEXATIOUS ACTIVITIES ARE STOPPED AND COSTS SO FAR OWED TO THE SMMTL ARE URGENTLY PAID AS PER COURT ORDERS.

MOSQUE IS THE HOUSE OF ALLAH AND DOES NOT BELONG TO ANY HUMAN BEING. THE BOARD OF TRUSTEES OF THE SOUTHAMPTON MEDINA MOSQUE TRUST LIMITED (SMMTL) HAS NO CLAIM TO THE MOSQUE OR ITS ASSETS.

THE BOARD FEELS CONCERNED AND SADDENED THAT MONEY SO BADLY NEEDED TO IMPROVE THE MOSQUE HAS HAD TO BE USED IN DEFENDING THE COMPLETELY FRIVOLOUS CASE BROUGHT BY MR ASLAM. THE JUDGE HAS RULED THAT MR ASLAM HAS NO PROSPECT OF SUCCEEDING IN HIS CLAIM AND HAS SUMMARILY DISMISSED THE CLAIM.
